SCHEME FOR SUPPLY OF T.V SETS TO INDUSTRIAL ESTABLISHMENTS/ LABOUR WELFARE CENTRES/CLUBS/RECREATION ROOMS.

INTRODUCTION:

With the linking of various places in the country with the Television network, it has become essential to provide T.V. sets to the Industrial Establishments, Labour Welfare Centres/Clubs/Recreation Rooms for the benefits of the workers employees engaged in various industries. By providing T.V. Sets, the workers/employees will be able to witness programmes of national importance and inculcate in themselves ideas of national integration besides broadening their outlook.

AREA OF OPERATION:

The T.V. Sets may be provided to the industrial establishments, Labour Welfare Centres run by Government of Goa and clubs, recreation rooms run by registered trade unions having minimum members of 300 workers. Preference shall be given to applicants having place of entertainment in labour concentrated areas.

PROCEDURE FOR SANCTION:

- a) T.V. Sets (coloured) will be purchased by the Welfare Fund, initially and entrusted with the concerned industrial establishments. The cost of T.V. Sets including all accessories should not exceed Rs. 25,000/- (Rupees twenty five thousand only). T.V. Sets shall be preferably purchased from the open market by inviting quotations. However, if the management is desirous of providing a Black and White T.V. Set, full cost of the set will be reimbursed by the Fund subject to a maximum of Rs. 12,000/-(Rupees twelve thousand only)
- b) The management /Union/Government shall enter into an agreement with the Welfare Board to maintain the T.V. Set in good working condition at all times and exhibit programmes for the benefit of their workers on day-to-day basis.
- c) The incidental expenses incurred in connection/ with the operation of T.V. Sets etc.. will have to be borne by the concerned Management/Union/Club.
- d) Suitable accommodation for installation of T.V. Sets shall be provided by the management.
- e) If the Management/Union/Government fails to comply with the provisions of the schemes/agreement, the Goa Labour Welfare Board shall have the right to withdraw T.V Set if it is supplied departmentally or recover the grant-in-aid amount with interest thereon at the prescribed rate if the T.V is provided on grant-in-aid basis.
- f) Request of a Management / Union for supplying T.V. Set who has already purchased Black & White T.V. Set under the scheme shall be entertained only after the return of previous T.V. Set in Black & White.
- g) Not more than one T.V. Set shall be provided to an Industrial Establishment though the same establishment may have a club sponsored by the Union.
- h) The Scheme No. 4 which was earlier defunct has not been revived w.e.f. 25.03.2011 as per the Resolution taken by the Board in its Meeting held on 25.03.2011.
